

## **Customer Reviews**

Considering how bare bones a supplement is, you would think they could get the numbering for the sections correct. You would be wrong. One example is in Appendix P (see photo). The numbering is totally off for the entire Uniform Foreign Country Money Judgments Recognition Act, making it inaccurate. "Except as otherwise provided in subsection (b), this [act] applies..." Except subsection b is labeled as subsection 2. If you're looking around for subsection b, c, etc., you should actually be looking for subsections 2,3, etc. This is a small typographical mistake, but a really annoying one. If I hadn't looked up the act online and was just referring to this book, I would scratching my head asking if there was some other section not included in the supplement. Also the text in Appendix O for the UFMJR appears to be outdated. I am not sure when the changes were made, but, for example, section 6 looks completely different on Westlaw. That appendix also references some random section numbers throughout that are nowhere to be found in the supplement (similar to Appendix P).

Excellent book with the others I have on the subject. I recommend the book and the seller.
