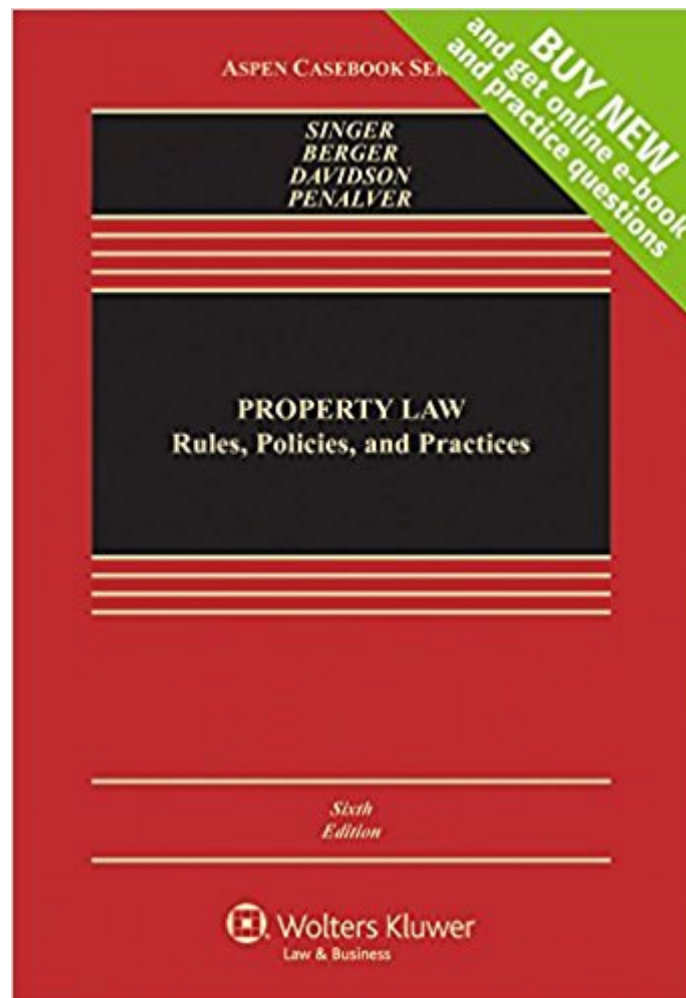

He is author of *Animal Liberation*, first published in 1975, and is widely credited with triggering the modern animal-rights movement. His *Companion to Ethics* is one of the most widely used texts in ethics, and *Rethinking Life and Death* received the 1995 National Book Council's Banjo Award for non-fiction. He was the foundation president of the International Association of Bioethics.
