

A useful overview that provides clear, concise explanations of topics commonly covered in a business associations class. It went into more state and lower federal courts' cases than I thought necessary- those cases aren't particularly useful or relevant, not knowing what state you're in law school in for state law, etc. The overview of circuit splits was helpful, just a waste of time on specific state cases and such. The biggest issue is the huge number of errors. Spelling errors, missing periods and commas, weird spacing issues and much more. There are pages with 3 or more errors on a single page, it's pretty ridiculous. I'm wondering if someone edited this book at all. All of these errors just left me wondering if some of the content is full or errors as well, which is worrisome.

Warning: This book has not been properly proofread. I'm on page 62 and continuing reading this book, because I find it pretty informative and readable enough. Yet the errors

(typographical/grammatical/whatever) are annoying and sporadic. So, my recommendation: I would recommend this book overall, with the caveat that there will be typos and other sporadic symptoms of lack of proofreading. You just have to ask yourself if you're willing to spend thirty dollars on such a product. Getting this book used would be a good idea in my opinion, because what is the use in spending the extra money to get something in mint condition when it's mint condition is full of typos?

Very useful for the aspiring legal scholar or business entrepreneur--this book provides a great introduction and foundation to business associations (aka "business enterprise" at some law schools). I would give it the full 5-star rating, but the typos are unacceptable. I am far from a "grammar elitist", and I will forgive most errors--but repeatedly missing periods, misspelling simple words like "of" and "to".... that really detracts from the author's credibility in my humble opinion. I would still recommend this book to anyone who does not mind glaring grammatical errors. It does contain a vast amount of useful information allowing novice professionals to learn about LLPs, LLCs, C Corps, S Corps, partnerships, etc.

This book has just enough material to give an introductory sweep of the subject matter, however it does not go deep enough into to be useful for my law school course. Also, it does not dive into case law enough.

This is a very good source of reference materials on business associations.
