

New to the 2nd edition, Part III extends the information from Parts I and II to address music therapy research in the schools, including students with disabilities in beginning band, and issues related to the family of students with disabilities. *Music in Special Education* (2nd edition), is an essential text to prepare effective future music educators and music therapists for the real world.
